### 2021 NON-NOMAR REALTOR® MLS Fee Schedule

**REALTOR® MLS MEMBERSHIP** – Every REALTOR® must file an application to join the MLS once the principal Broker has joined and pay the appropriate fees.

\*Agent MLS dues are pro-rated quarterly and NON-REFUNDABLE.

Beginning May 1, 2021, agent MLS fees will be billed quarterly. Fees for the quarter that starts July 1<sup>st</sup> will be invoiced on May 1<sup>st</sup>, due on June 1<sup>st</sup> and delinquent on July 1<sup>st</sup>. Accounts paid after June 30<sup>th</sup> will incur a \$25.00 delinquent fee that is due with payment. On July 1<sup>st</sup>, the User's MLS Services will be deactivated for nonpayment.

Fees for the quarter that starts on Oct 1<sup>st</sup> will be invoiced on August 1<sup>st</sup>, due on September 1<sup>st</sup> and delinquent on October 1<sup>st</sup>. Accounts paid after September 30<sup>th</sup> will incur a \$25.00 delinquent fee that is due with payment. On October 1<sup>st</sup>, the User's MLS Services will be deactivated for nonpayment.

Fees for the quarter that starts on January 1<sup>st</sup> will be invoiced on November 1<sup>st</sup>, due on December 1<sup>st</sup> and delinquent on January 1<sup>st</sup>. Accounts paid after December 31<sup>st</sup> will incur a \$25.00 delinquent fee that is due with payment. On January 1<sup>st</sup>, the User's MLS Services will be deactivated for nonpayment.

Fees for the quarter that starts on April 1<sup>st</sup> will be invoiced on February 1<sup>st</sup>, due on March 1<sup>st</sup> and delinquent on April 1<sup>st</sup>. Accounts paid after March 31<sup>st</sup> will incur a \$25.00 delinquent fee that is due with payment. On April 1<sup>st</sup>, the User's MLS Services will be deactivated for nonpayment.
